RESOLUTION NO. 100, S-2022

AUTHORIZING HON. MAYOR LEOPOLDO N. BATAOIL TO LEASE OUT STALLS IN THE LINGAYEN PUBLIC MARKET AND LINGAYEN COMMON TERMINAL ON BEHALF OF THE MUNICIPALITY OF LINGAYEN AND TO SIGN THE CONTRACTS OF LEASE AND OTHER DOCUMENTS NECESSARY FOR THE PURPOSE.

WHEREAS, stalls in the Lingayen Public Market and Lingayen Common Terminal are available for lease to qualified applicants pursuant to the provisions of Ordinance No. 18, S-2014, otherwise known as the Lingayen Market Code and other existing municipal ordinances;

WHEREAS, the leasing out of these available stalls will generate income for the Municipal Government of Lingayen;

WHEREAS, the Municipality of Lingayen needs to be represented in the signing of the Contracts of Lease;

WHEREAS, Section 22 (c) of the Local Government Code of 1991 provides that "Unless otherwise provided in this Code, no contracts may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned";

WHEREFORE, on motion of SBM Ricardo R. Ferrer, duly seconded by SBM Jonathan T. Ramos, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize Hon. Mayor Leopoldo N. Bataoil to lease out stalls in the Lingayen Public Market and Lingayen Common Terminal on behalf of the Municipality of Lingayen and to sign the Contracts of Lease and other documents necessary for the purpose.

RESOLVED FURTHER, that copies of this resolution be furnished to the Municipal Mayor, Municipal Treasurer, and Market Supervisor, for their information and records.
