RESOLUTION NO. 104, S-2022

AUTHORIZING HON. MAYOR LEOPOLDO N. BATAOIL TO SPONSOR AND PAY FOR THE MEMBERSHIP REGISTRATION OF FOUR THOUSAND (4,000) PUBLIC SCHOOL CHILDREN FROM THE MUNICIPALITY OF LINGAYEN TO THE BOY SCOUTS OF THE PHILIPPINES.

WHEREAS, the Boy Scouts of the Philippines Pangasinan-San Carlos City Council wrote to the Local Chief Executive requesting the municipality to sponsor the membership registration of 4,000 young people enrolled in the public schools of both elementary and secondary schools in the municipality of Lingayen amounting to ₱200,000.00 to be charged from the Mayor's Office Other MOOE budget; the same was endorsed to the Sangguniang Bayan for legislative action;

WHEREAS, DILG Memorandum Circular No. 11, S-2018 (Support to the Boy Scouts of the Philippines) provides for the "sponsorship and pay for the registration fees of public-school children in their areas xx";

WHEREAS, in the previous year, the Municipal Government of Lingayen extended its support to the Council by sponsoring 1,000 scouts from the municipality; and the sponsorship of another 4,000 scouts for this year reinforces its commitment to support the scouting movement to develop the physical, mental, and spiritual development of young people in Lingayen with strong focus on outdoor and survival skills;

WHEREAS, the LGU believes that scouting can be an avenue to stop social maladies caused by vices and drugs which corrupts many individuals especially boys;

WHEREAS, since the request is for a noble intention which is worthy of favorable consideration, the Sangguniang Bayan has decided to pass this resolution;




