REQUESTING CENPELCO TO REMOVE THEIR OLD AND LEANING UTILITY POLES AT BARANGAY QUIBAOL, LINGAYEN AND TO REMOVE ANOTHER UTILITY POLE AT SOLIS STREET, BARANGAY POBLACION, THIS MUNICIPALITY.

WHEREAS, several utility poles that are rotten or old and already leaning still stands within the territorial jurisdiction of Lingayen especially at Barangay Quibaol, Lingayen and in Solis Street, in Barangay Poblacion, this municipality;

WHEREAS, said utility poles are already considered unsafe and cause significant risks to the public;

WHEREAS, despite several reports lodged to the concerned electric company, the matter remains unaddressed;

WHEREAS, residents in the areas mentioned are already perplexed and fearful of the possible damage/s it might cause to lives and properties, and are fervently hoping and praying that the same be inspected, fixed, replaced, and removed by CENPELCO to prevent any tragedy from happening;

WHEREAS, apart from being dangerous, these old and leaning poles are also terrible eyesores along the roads and in the community;

WHEREFORE, on motion of SBM Rodulfo Luigi F. Morosi, duly seconded by SBM Jonathan T. Ramos, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request CENPELCO to remove their old and leaning Utility Pole at Barangay Quibaol, Lingayen and to remove another Utility Pole at Solis Street, Barangay Poblacion, this municipality.

RESOLVED FURTHER, that a copy of this resolution be furnished to the CENPELCO Management for their information and appropriate action.


