THIS IS TO CERTIFY *that at the Regular Session duly constituted of the Sangguniang Bayan of Lingayen, Pangasinan held on October 24, 2022, at Lingayen, Pangasinan, the following resolution was approved.*

RESOLUTION NO. 110, S-2022

DECLARING SK RESOLUTION NO. 02, S-2022 OF THE SANGGUNIANG KABATAAN COUNCIL OF BARANGAY LIBSONG EAST, LINGAYEN, PANGASINAN OPERATIVE.

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Lingayen, Pangasinan as a legislative body is empowered to review ordinances authorizing annual or supplemental appropriations of barangays in the manner prescribed by law;

WHEREAS, the Sangguniang Kabataan of Barangay Libsong East, Lingayen, Pangasinan submitted its Supplemental Budget No. 1, CY-2022, which was approved on September 03, 2022 through SK Resolution No. 02, S-2022;

WHEREAS, the Committee on Appropriation & Finance of the Sangguniang Bayan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, conducted preliminary review and study on said budget and hereby recommends to declare it *OPERATIVE* effective as of the date fixed in the Appropriation Ordinance subject however to the following condition, observation and recommendation:

1. That the utilization of appropriations from the expenditure program shall be in accordance with the provisions of Republic Act No. 10742 specifically Section 20 (c) thereof;
2. That the disbursement of appropriations for all programs, projects and activities shall be in accordance with the Annual Barangay Youth Investment Plan (ABYIP) of the barangay;
3. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act);
4. In the appropriation, release, planning and budgeting process, the SK's shall observe the policies and procedures prescribed under DBM-NYC-DILG Joint Memorandum Circular No. 2019-1;


