RESOLUTION NO. 119, S-2022

REQUESTING PHILIPPINE RED CROSS THRU ITS SECRETARY GENERAL, DR. GWENDOLYN PANG TO PUT UP/ESTABLISH THEIR PANGASINAN CHAPTER OFFICE IN THE MUNICIPALITY OF LINGAYEN, PANGASINAN.

WHEREAS, Lingayen is in the heart of the fifth biggest province in the country in terms of population - the capital town of the great province of Pangasinan;

WHEREAS, it is best believed that this premier municipality shall house the main provincial office of the Philippine Red Cross (PRC);

WHEREAS, with great pride and honor, the constituency of Lingayen would like to take part in the heroism of the PRC by becoming full-fledged members, volunteers, or donors, and would also like to become part in fulfilling PRC's objectives in providing quality life-saving services that protect life and dignity of the Filipinos in vulnerable situations;

WHEREAS, this goal can be made even more possible when the Pangasinan Chapter Office of PRC is brought physically near to these people;

WHEREAS, it would also be highly beneficial to the existing PRC blood banks located in Alaminos City, Dagupan City, and San Carlos City if the main provincial office is erected here in Lingayen;

WHEREAS, pursuant to RA 7160, otherwise known as the Local Government Code of 1991, every local government unit (LGU) is mandated to render quality and affordable health services to their constituents, and shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities enumerated therein; wherefore the establishment of the PRC in this municipality is significant to aid this LGU to carry out this mandate in the exigency of public service;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM John Marc M. Lopez, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request Philippine Red Cross thru its Secretary General, Dr. Gwendolyn Pang to put up/establish their Provincial Chapter Office in the Municipality of Lingayen, Pangasinan.



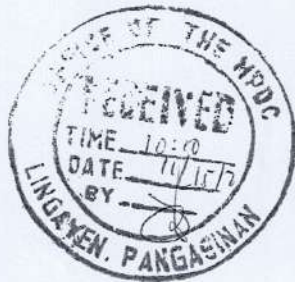
