RESOLUTION NO. 131 S-2022

AUTHORIZING MAYOR LEOPOLDO N. BATAOIL TO NEGOTIATE, ENTER INTO AND SIGN THE CONTRACT OF LEASE BETWEEN THE MUNICIPAL GOVERNMENT OF LINGAYEN AND LV FISHPORT FOR THE LEASE OF THE LINGAYEN FISHPORT SITUATED AT BARANGAY POBLACION, LINGAYEN, PANGASINAN.

WHEREAS, the Municipal Government of Lingayen is the owner of the Municipal Fishport located at Casiano Jimenez Street, Barangay Poblacion, Lingayen, Pangasinan;

WHEREAS, LV Fishport is desirous to lease said property for fish market retail and wholesale of agricultural raw materials, live animals and other essential products for a period of two (2) years;

WHEREAS, the amount of monthly rental rate is Fifty Thousand Pesos (P50,000.00) due and payable every end of the month;

WHEREAS, Section 444 (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Municipal Mayor upon authorization by the Sangguniang Bayan shall represent the municipality in all its business transactions and sign on its behalf all bonds, contracts and obligations, and such other documents made pursuant to law or ordinance;

WHEREAS, a copy of the subject Contract of Lease shall form as an integral part of this Resolution.

WHEREFORE, on motion of SBM Rodulfo Luigi F. Morosi, duly seconded by SBM Jonathan T. Ramos, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize Mayor Leopoldo N. Bataoil to negotiate, enter into and sign the Contract of Lease between the Municipal Government of Lingayen and LV Fishport for the lease of the Lingayen Fishport situated at Barangay Poblacion, Lingayen, Pangasinan.

RESOLVED FURTHER, that copies of this Resolution be furnished to Mayor Leopoldo N. Bataoil and to Mr. Leo L. Estrada, Owner of LV Fishport for their information and guidance.
