RESOLUTION NO. 132 S-2022

REQUESTING THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF THE LINGAYEN LIVELIHOOD DEVELOPMENT CENTER AMOUNTING TO THREE HUNDRED MILLION PESOS (P300,000,000.00) AND THE CONSTRUCTION OF LDRRM OPERATION CENTER AMOUNTING TO TWO HUNDRED MILLION PESOS (P200,000,000.00), THIS MUNICIPALITY.

WHEREAS, in support to the flagship infrastructure program of the national government better known as “Build, Better, More” which aims to accelerate infrastructure in the Philippines, the Municipal Government of Lingayen has earmarked high-impact infrastructure projects aimed at strengthening its local economy;

WHEREAS, the proposed Lingayen Livelihood Development Center is envisioned to support and strengthen Local Economic Enterprise, encourage and create more opportunities for Local Economic Development and Investment Promotion, and establish an excellent training avenue for the Cooperative Development Authority;

WHEREAS, the LDRRM Operation Center on the other hand, will capacitate the local government in all its climate change mitigation and adaptation programs and disaster preparedness initiatives and activities through a first-rate building complex;

WHEREAS, the projects are expected to benefit 110,000 Lingayenenses and over a thousand more from neighboring towns of the second district of Pangasinan;

WHEREAS, infrastructure development is of primary importance as it is a necessary element in improving agriculture, tourism, general economic activity and even governance;

WHEREFORE, on motion of SBM Jonathan T. Ramos, duly seconded by SBM John Marc M. Lopez, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request the Department of Budget and Management (DBM) to allocate funds for the construction of the Lingayen Livelihood Development Center amounting to Three Hundred Million Pesos (P300,000,000.00) and the construction of LDRRM Operation Center amounting to Two Hundred Million Pesos (P200,000,000.00), this municipality.

RESOLVED FURTHER, that a copy of this resolution be furnished to Hon. Amenah F. Pangandaman, Secretary, Department of Budget and Management (DBM), San Miguel, Manila for her information and favorable action.
