APPROVING THE APPLICATION OF MR. CHESTER MARK F. FLORES TO ESTABLISH AND OPERATE AN AMUSEMENT PARK/RIDES AT THE RECLAIMED AREA, CASIANO JIMENEZ STREET, BARANGAY POBLACION, LINGAYEN, PANGASINAN.

WHEREAS, presented for deliberation by the August Body is the letter of intent of Mr. Chester Mark F. Flores to establish and operate an Amusement Park/Rides at the Reclaimed area in relation to the forthcoming 2023 Lingayen Capital Town Festival;

WHEREAS, fiesta celebrations are made merrier by the presence of amusement parks/rides which serve as places of recreation and leisure for adults, teenagers and children;

WHEREAS, Amusement Parks are considered "happy places" for many who are enticed by the fun and adventure vibe and for work-stressed people in need of relaxation;

WHEREAS, the presence of amusement park/rides in the said location is expected to draw more people to this capital town as well as add color, fun and excitement to the fiesta celebration;

WHEREAS, the operation of the amusement park/rides must be monitored by the Municipal Engineering Department to ensure that the operator adheres to necessary safety measures on the operation and maintenance of the rides and in order to prevent the occurrence of accidents;

WHEREAS, after due deliberation, the Honorable Council have decided to allow the establishment and operation of the Amusement Park/rides at the Reclaimed area (adjacent to the Lingayen Common Terminal) from November 16, 2022 to January 15, 2023 to give ample time to the people to enjoy the rides and create beautiful memories with their family and friends;

WHEREFORE, on motion of SBM Rodolfo Luigi F. Morosi, duly seconded by SBM Jonathan T. Ramos, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to approve the application of Mr. Chester Mark F. Flores to establish and operate an Amusement Park/rides at the Reclaimed Area, Casiano Jimenez Street, Barangay Poblacion, Lingayen, Pangasinan.
