RESOLVED FURTHER, that copies of this resolution be furnished to the aforementioned personalities for their information and record.

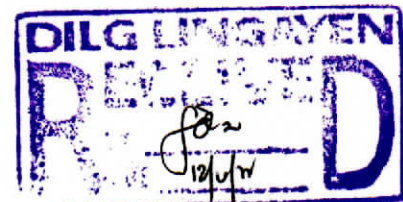
