AUTHORIZING MAYOR LEOPOLDO N. BATAOIL TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH PANGASINAN STATE UNIVERSITY FOR THE INTERNSHIP PROGRAM OF BS SOCIAL WORK STUDENTS.

WHEREAS, the Pangasinan State University has instituted an internship program as part of the curriculum for its Bachelor of Science in Social Work students in order to provide them with adequate actual work experience to augment their formal education;

WHEREAS, the Municipal Government in its desire to provide relevant exposure to student interns and to help enhance their training and development, has agreed to support the internship program with the hope of ensuring a continuous supply of highly qualified government and private personnel;

WHEREAS, the theories learned and activities done inside the University would become more effective when supplemented with an actual internship practices on areas of training assigned to the students necessary to complete the maximum internship hours' requirement;

WHEREAS, the Sangguniang Bayan has reviewed the draft Memorandum of Agreement that will govern the duties and responsibilities of the parties and the same has been found to be reasonable and in accordance with law;

WHEREAS, Section 22 (c) of the Local Government Code of 1991 states that unless otherwise provided, no contract maybe entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;
