**RESOLUTION NO. 146, S-2022**

**REQUESTING THE MUNICIPAL MAYOR, HON. LEOPOLDO N. BATAOIL TO RECOMMENCE THE GRANT OF TRAVELLING ALLOWANCE TO MAFC AND MFARMC CHAIRMEN AND THEIR MEMBERS PER QUARTERLY MEETING.**

WHEREAS, joint Resolution No. 001, S-2022 of MAFC and MFARMC, entitled, "*Requesting the Honorable Sangguniang Bayan Members to pass a resolution requesting Honorable Mayor Leopoldo N. Bataoil for the approval of the retention of quarterly travelling allowance of ₱1,500.00 for the MAFC and MFARMC Chairmen and ₱300.00 for each MAFC and MFARMC Member per meeting attendance for Year 2023*" was submitted to the Sangguniang Bayan for legislative action;

WHEREAS, the Municipal Agricultural and Fishery Council (MAFC) and Municipal Fisheries and Aquatic Resources Management Council (MFAMC) of Lingayen acts as an advisory body to the Local Government Unit of Lingayen to ensure the success of government programs and projects pursuant to Executive Order No. 116, Series of 1987;

WHEREAS, the officers and members of the MAFC and MFARMC act as implementing arms of the Municipal Agriculture Office in the monitoring and validation of programs and projects of the Department of Agriculture;

WHEREAS, the grant of quarterly travelling allowance to MAFC and MFARMC Chairmen and their members was halted due to the COVID-19 crisis in which the fund allocation was diverted to livelihood projects; since restrictions eased up, they were back at performing their duties and functions, and in holding their regular quarterly meetings;

WHEREAS, beginning Calendar Year 2023, MAFC and MFARMC Chairmen will receive ₱1,500.00 quarterly travelling allowance, while their members will receive ₱300.00 per meeting attendance which will be charged from the MAFC and MFARMC budget allocation under Other Special Purpose Appropriation;

WHEREFORE, on motion of SBM Ricardo R. Ferrer, duly seconded by SBMs Jay Mark Kevin D. Crisostomo and John Marc M. Lopez, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request the Municipal Mayor, Hon. Leopoldo N. Bataoil to recommence the grant of travelling allowance to MAFC and MFARMC Chairmen and their Members per quarterly meeting.

RESOLVED FURTHER, that copies of this resolution be furnished to the Municipal Mayor, Municipal Agriculturist, the Local Finance Committee, and the Chairmen of MAFC and MFARMC, for their information and reference.

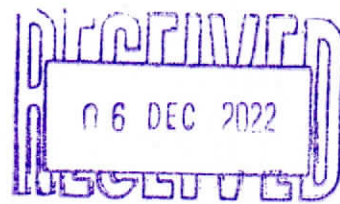
