RESOLUTION NO. 149, S-2022

AUTHORIZING THE MUNICIPAL MAYOR, HONORABLE LEOPOLDO N. BATAOIL TO ENTER INTO A MEMORANDUM OF AGREEMENT/NON-DISCLOSURE AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FIELD OFFICE I (DSWD FOI) RELATIVE TO THE TRANSFER OF PERSONAL DATA OF 4Ps BENEFICIARIES IN ACCORDANCE WITH THE DATA PRIVACY ACT AND THE DSWD DATA SHARING AND PRIVACY POLICIES AND GUIDELINES.

WHEREAS, the Sangguniang Bayan received a letter from the Municipal Mayor dated November 9, 2022 requesting for a resolution authorizing him to enter into a Memorandum of Agreement (MOA) with DSWD FOI;

WHEREAS, consistent with the provisions of the Administrative Code of 1987 and Republic Act 7160, otherwise known as the Local Government Code of 1991, the DSWD is mandated to provide assistance to local government units (LGUs), non-government organizations (NGOs), other national government agencies (NGAs), people's organizations (POs) and members of civil society in effectively implementing programs, projects, and services that will alleviate poverty and empower disadvantaged individuals, families and communities for an improved quality of life;

WHEREAS, the Local Government Unit of Lingayen is mandated to serve the disadvantaged/marginalized sector through the provision and implementation of protective social program and services such as the Pantawid Familyang Pilipino Program (4Ps) of the national government, implemented through the DSWD;

WHEREAS, the 4Ps is a national poverty reduction strategy which provides conditional cash grants to the poorest of the poor to improve the health, nutrition status and education of their children;

WHEREAS, the DSWD shall provide the Municipality of Lingayen, when so requested, with 4Ps information and data vital to the provision of protective social programs and services in consonance with the proper use and protection of shared data, particularly on relevant stipulations under the Data Privacy Act and DSWD data-sharing and privacy policies and guidelines;

WHEREAS, Section 444 (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Municipal Mayor upon authorization by the Sangguniang Bayan shall represent the municipality in all its business transactions and sign on its behalf all bonds, contracts and obligations, and such other documents made pursuant to law or ordinance;

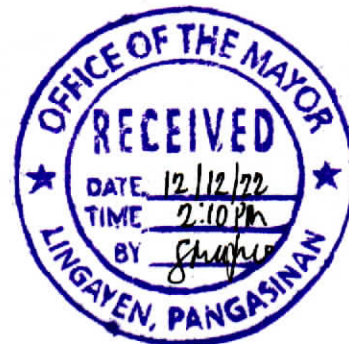
WHEREAS, the August Body found the stipulations in the Memorandum of Agreement/Non-Disclosure Agreement in order;

WHEREFORE, on motion of SBM Von Carlo E. Tiangson, duly seconded by SBM Rodolfo Luigi M. Morosi, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Municipal Mayor, Honorable Leopoldo N. Bataoil to enter into a Memorandum of Agreement/Non-disclosure Agreement with the Department of Social Welfare and Development Field Office I (DSWD FOI) relative to the transfer of personal data of 4Ps beneficiaries in accordance with the Data Privacy Act and DSWD Data Sharing and Privacy policies and guidelines.
