RESOLUTION NO. 170, S-2022

AUTHORIZING THE GRANT OF THREE THOUSAND PESOS (P3,000.00) FINANCIAL ASSISTANCE TO ALL JOB ORDER AND CONTRACT OF SERVICE WORKERS IN THE MUNICIPALITY OF LINGAYEN, PANGASINAN.

WHEREAS, Section 447 (a) (1) (viii) of R.A. 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Bayan has the power to determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees of the municipal government;

WHEREAS, the Municipal Job Order and Contract of Service Workers play an important role in the economic growth and development of the LGU by helping ensure the delivery of best public service to the people;

WHEREAS, their efforts and assistance should be rewarded as a token of their faithful and diligent service through the grant of financial assistance and to serve as motivation for them to work harder and contribute more to the plans, programs and activities of the municipal government;

WHEREAS, the Municipal Government has allocated funds to help ease the financial burdens of the workers brought about by the worldwide increase of prices of most, if not all, commodities;

WHEREAS, the financial assistance also serves as Christmas gift to the hardworking Job Order and Contract of Service workers of the municipality which they can share with their loved ones in this special time of the year;

WHEREFORE, on motion of the House, duly seconded, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the grant of Three Thousand Pesos (P3,000.00) financial assistance to all Job Orders and Contract of Service Workers in the Municipality of Lingayen, Pangasinan.
