RESOLVED FURTHER, that copies of this resolution be furnished to the Local Finance Committee and the Municipal Mayor for their information and guidance.

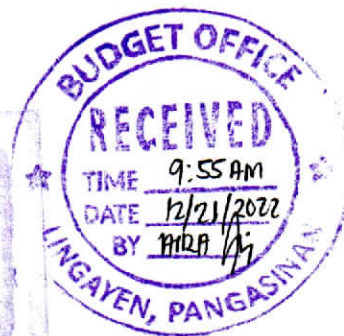
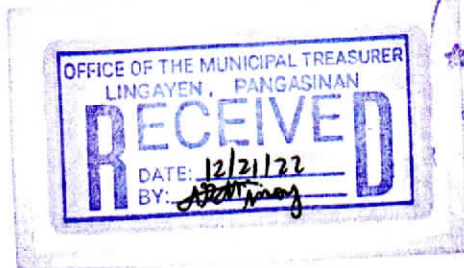
