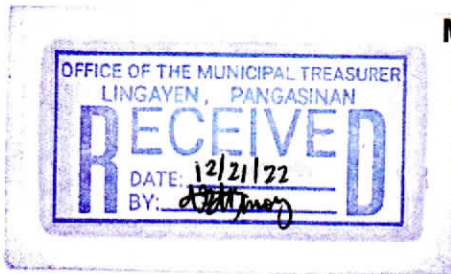
RESOLVED FURTHER, that copies of this resolution be furnished to the Local Finance Committee for their information and guidance.
