RESOLUTION NO. 056, S-2022

RESOLUTION APPROVING AND GRANTING THE ACCREDITATION OF BHW OF LINGAYEN, PANGASINAN RHU II IN THE MUNICIPALITY OF LINGAYEN, PROVINCE OF PANGASINAN.

WHEREAS, Section 34 of the Local Government Code of 1991 (Book 1, Chapter 4) states that local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

WHEREAS, on June 15, 2022, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2022-083, on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives of the Local Special Bodies;

WHEREAS, the BHW of Lingayen, Pangasinan RHU II through its president, Consuelo D. Garcia, has signified its intention to be an accredited CSO in the Municipality of Lingayen, Province of Pangasinan to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;

WHEREAS, the BHW of Lingayen, Pangasinan RHU II has satisfactorily complied with the requirements and criteria for accreditation as civil society organization in accordance with the procedures and guidelines set forth in DILG MC 2022-083;

WHEREFORE, on motion of SBM Rodulfo Luigi F. Morosi, duly seconded by SBMs John Marc M. Lopez and Jonathan T. Ramos, be it:

RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Bayan to approve and grant the accreditation of BHW of Lingayen, Pangasinan RHU II in the Municipality of Lingayen, Province of Pangasinan.

RESOLVED FURTHER, that this accreditation is effective only until June 30, 2025.

RESOLVED FURTHERMORE, that copies of this resolution be furnished to the Honorable Mayor, Leopoldo N. Bataoil; BHW of Lingayen, Pangasinan RHU II President, Consuelo D. Garcia, and the Municipal Legal Officer for their information and guidance.


