RESOLUTION APPROVING AND GRANTING THE ACCREDITATION OF NAMOLAN OFW FAMILY ASSOCIATION IN THE MUNICIPALITY OF LINGAYEN, PROVINCE OF PANGASINAN.

WHEREAS, Section 34 of the Local Government Code of 1991 (Book 1, Chapter 4) states that local government units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

WHEREAS, on June 15, 2022, the Department of the Interior and Local Government (DILG) issued Memorandum Circular No. 2022-083, on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representatives of the Local Special Bodies;

WHEREAS, the Namolan OFW Family Association through its president, Perlita Senting, has signified its intention to be an accredited CSO in the Municipality of Lingayen, Province of Pangasinan to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;

WHEREAS, the Namolan OFW Family Association has satisfactorily complied with the requirements and criteria for accreditation as civil society organization in accordance with the procedures and guidelines set forth in DILG MC 2022-083;


