WHEREAS, the Lingayen OFW Family Association through its president, Maria Teresa Broqueza, has signified its intention to be an accredited CSO in the Municipality of Lingayen, Province of Pangasinan to pursue an active partnership with the Local Government Unit in the pursuit of local autonomy and nation building;

WHEREAS, the Lingayen OFW Family Association has satisfactorily complied with the requirements and criteria for accreditation as civil society organization in accordance with the procedures and guidelines set forth in DILG MC 2022-083;



RESOLVED FURTHER, that this accreditation is effective only until June 30, 2025.


