RESOLUTION NO. 080, S-2022

AFFIRMING THE REALIGNMENT OF SPECIFIED PROJECTS CONSTITUTING THE BUDGET FOR LIVELIHOOD SKILLS TRAINING FOR THE VICTIM SURVIVORS OF VIOLENCE AGAINST WOMEN AND CHILDREN (VAWC) AND TRAFFICKED IN PERSONS (TIP) UNDER THE LOCAL COMMITTEE ON ANTI-TRAFFICKING AND VIOLENCE AGAINST WOMEN AND THEIR CHILDREN (LCAT-VAWC) TO THE AWARENESS CAMPAIGN FUND ON R.A. 9262 AND R.A. 9208 (AS AMENDED), BOTH APPROPRIATED UNDER THE GENERAL FUND OF THE ANNUAL BUDGET FOR FY 2022, THIS MUNICIPALITY.

WHEREAS, the Annual Budget for FY 2021 of the Municipality of Lingayen was approved on December 22, 2021;

WHEREAS, on February 07, 2022, the Sangguniang Bayan (SB) has passed and approved Resolution No. 576, S-2022, entitled, "Affirming the specified projects constituting the budget for Local Committee on Anti-Trafficking and Violence against Women and their Children under General Fund of the Annual Budget for FY 2022, this municipality" upon the request of the Municipal Social Welfare and Development (MSWD) Officer;

WHEREAS, on September 05, 2022, the MSWD Officer again requested the SB for the affirmation to realign the budget for *Livelihood Skills Training for Victim-Survivors of VAWC and TIP* in the amount of One Hundred Thousand Pesos (₱100,000.00) to the budget of the *Awareness Campaign Fund on RA 9262 and RA 9208 (as amended)* amounting to One Hundred Thousand Pesos (₱100,000.00) as well;

WHEREAS, merging the budget of the two specified projects will generate the new grand total for the Awareness Campaign Fund on RA 9262 and RA 9208 (as amended) - Two Hundred Thousand Pesos (P200,000.00), break down as follows:

WHEREAS, there is a need for the SB to affirm the herein realigned specified projects constituting the budget for Livelihood Skills Training for the victim survivors of VAWC and TIP to the Awareness Campaign on RA 9262 and RA 9208 (as amended) to conform with the implementation by the Municipal Social Welfare and Development Office;


WHEREFORE, on motion of SBM Jonathan T. Ramos, duly seconded by SBM John Marc M. Lopez, be it:

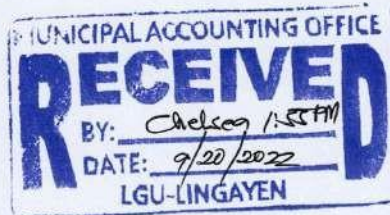
