RESOLUTION NO. 081, S-2022

REQUESTING HON. CONGRESSMAN RON P. SALO OF KABAYAN PARTYLIST TO ALLOCATE FUNDS IN THE AMOUNT OF TWO HUNDRED MILLION PESOS (P200,000,000.00) FOR THE CONSTRUCTION OF RIVER EMBANKMENT WITH SLOPE PROTECTION AT BARANGAY BALOCOC, THIS MUNICIPALITY.

WHEREAS, Section 17 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, mandates that Local Government Units shall endeavor to provide basic services and facilities to the people;

WHEREAS, the Municipality of Lingayen is deeply concerned about the frequent flooding at Barangay Balococ, this town, due to overflow of the Agno River caused mainly by continuous rain wrought about by southwest monsoon and typhoons which visited the country of late;

WHEREAS, the lives and properties of the people living in the area are heavily impacted, not to mention the disastrous effect on the environment and economic condition of the said barangay;

WHEREAS, there is an imperative need to address said problem and to adopt preventive measures to prevent recurring flooding in the area through the establishment of river embankment with slope protection;

WHEREAS, the Municipal Government has no financial capability to undertake the project on its own, hence, the need for financial assistance from national officials and agencies;

WHEREFORE, on motion of SBM John Marc M. Lopez, duly seconded by SBM Jonathan T. Ramos, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request Hon. Congressman Ron P. Salo of Kabayan Partylist to allocate funds in the amount of Two Hundred Million Pesos (P200,000,000.00) for the construction of river embankment with slope protection at Barangay Balococ, this municipality.

RESOLVED FURTHER, that a copy of this resolution be furnished to Congressman Ron P. Salo of Kabayan Partylist, House of Representatives, Quezon City, for his information and favorable action.


