RESOLUTION NO. 083, S-2022

AUTHORIZING THE MUNICIPAL VICE MAYOR, HON. MAC DEXTER G. MALICDEM AS OFFICIAL SIGNATORY OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN IN ALL ITS BUSINESS TRANSACTIONS WITH THE LAND BANK OF THE PHILIPPINES (LBP), DEVELOPMENT BANK OF THE PHILIPPINES (DBP), AND PHILIPPINE VETERANS BANK (PVB).

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides for a system of check and balance by granting separate powers to the Executive and Legislative Departments of Local Government Units;

WHEREAS, Section 445 (1) of the same Code, grants the Municipal Vice Mayor as the Presiding Officer of the Sangguniang Bayan to sign all warrants drawn on the Municipal Treasury for all expenditures appropriated for the operation of the Sangguniang Bayan;

WHEREAS, the Municipality of Lingayen have funds to be deposited for safekeeping and withdrawal in accordance to disbursement procedures as provided for by law;

WHEREAS, there is a necessity to authorize the Municipal Vice Mayor as official signatory of the Sangguniang Bayan in all its business transactions with the aforesaid banks;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBMs John Marc M. Lopez and Jonathan T. Ramos, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Municipal Vice Mayor, Hon. Mac Dexter G. Malicdem as official signatory of the Sangguniang Bayan of Lingayen in all its business transactions with the Land Bank of the Philippines (LBP), Development Bank of the Philippines (DBP), and Philippine Veterans Bank (PVB).





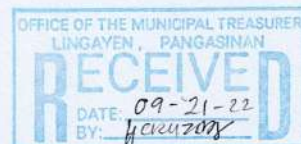
