AUTHORIZING HONORABLE MAYOR LEOPOLDO N. BATAOIL TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH FOOD TERMINAL INCORPORATED ON BEHALF OF THE MUNICIPALITY OF LINGAYEN.

WHEREAS, Food Terminal Incorporated, a Government-Owned and Controlled Corporation, has adopted a strategic theme to support economic development and good governance by becoming the leading government owned food processing and distribution hub through the establishment of Regional Food Terminals (RTFs) in strategic locations nationwide;

WHEREAS, Lingayen is one of the leading producers of *bangus* (milkfish) and other fishery and aquatic resources in the Province of Pangasinan catering to domestic and international markets;

WHEREAS, Lingayen intends to partner with Food Terminal Incorporated by establishing a Lingayen Marine Processing and Cold Storage Facility Project within the municipality, with the end goal of increasing the productivity of Bangus Fishing Industry, and at the same time generating more work opportunities for fisherfolks in Lingayen, Pangasinan;

WHEREFORE, on motion of SBM John Marc M. Lopez, duly seconded by SBM Jonathan T. Ramos, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize Honorable Mayor Leopoldo N. Bataoil to enter into and sign the Memorandum of Understanding with Food Terminal Incorporated for the establishment of the Lingayen Marine Processing and Cold Storage Facility Project under such terms and conditions beneficial to the Municipality of Lingayen.




