KNOW ALL MEN BY THESE PRESENTS:

This CONTRACT AGREEMENT is entered into this 21st day of December 2020 by and between:

The MUNICIPALITY OF LINGAYEN, a local government unit duly created and existing under Philippine Law, represented by HON. LEOPOLDO N. BATAOIL, Municipal Mayor, herein after referred to as the "PROCURING ENTITY";

and

MARIQUETA G. NAVARRO, single proprietor, of legal age, married, Filipino citizen and resident of Barangay Domalandan West, Lingayen, Pangasinan and owner of MANY-MARIE STORE organized and existing by virtue of laws of the Republic of the Philippines, with store address at *Public Market*, *Barangay Poblacion*, *Lingayen*, *Pangasinan*, herein after referred to as the "SUPPLIER";

WITNESSETH:

WHEREAS, The PROCURING ENTITY has awarded to the SUPPLIER the *Purchase of Food Supplies (300 sacks of rice at 50 kilos per sack)) at MSWD Office, Lingayen, Pangasinan*, herein referred to as the "Works", and accepted the amount of *Seven Hundred Twenty Thousand Pesos Only (P720,000.00)* as the single calculated and responsive quotation;

- The SUPPLIER hereby covenants to execute and complete the "Works", and remedy any defects there within seven
 calendar days from the receipts of the Notice to Proceed and in conformity with the provisions of this CONTRACT
 AGREEMENT, in all respects.
- 4. The PROCURING ENTITY, hereby covenants to pay the SUPPLIER The Contract Price after completion of the "Works" according to the provisions of this CONTRACT AGREEMENT.

The SUPPLIER hereby agrees to refund the Local Government Unit (LGU) the amount considered to be overprized a declared by the Commission on Audit (COA).
