EXECUTIVE ORDER NO. 07, SERIES OF 2023

REORGANIZATION OF MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC)

WHEREAS, the Local Government Code of 1991 gives Local Government Units (LGUs) the powers necessary, appropriate or incidental for the maintenance of peace and order and preservation of the comfort and convenience of its inhabitants;

WHEREAS, DILG - Dangerous Drugs Board [DDB] Joint Memorandum Circular [JMC] No. 2018 - 01 dated May 21, 2018 provides implementing guidelines on the functionality and effectiveness of Local Anti-Drug Abuse Councils;

WHEREAS, the cited JMC specifies the composition of the Local Anti-Drug Abuse Councils and defines their roles and responsibilities;

WHEREAS, there is a need to update the composition of the Municipal Peace and Order Council due to the 2022 National and Local Elections, change of leadership of National Government Agency and LGU personnel;

NOW THEREFORE, I, LEOPOLDO N. BATAOIL, Municipal Mayor of Lingayen, Pangasinan, by virtue of the powers vested in me by law, do hereby reorganize the Municipal Anti-Drug Abuse Council of this municipality:

4. Perform other related responsibilities as maybe assigned by competent authorities.

Section 3. MEETINGS - The MADAC shall meet on a quarterly basis or as often as may be necessary.

Section 4. REPEALING CLAUSE - All prior issuances on the organization and function of this Council inconsistent herewith shall be deemed superseded by this order.

Section 5. EFFECTIVITY – This order shall take effect immediately.
