EXECUTIVE ORDER NO. 13, S-2022
IMPLEMENTING THE TARIFF RATE PRESCRIBED UNDER
SANGGUNIANG BAYAN (SB) ORDINANCE NO. 25, S-2014,
AS AMENDED BY SB ORDINANCE NO. 46, 2015.

WHEREAS, before the imposition of public transport restrictions brought about by the pandemic, the tariff rate for tricycles and pedicabs in the Municipality of Lingayen was laid down by *SB Ordinance No. 25, S-2014*, as amended by *SB Ordinance No. 46, 2015*.

WHEREAS, during the height of the COVID-19 pandemic, tricycles and pedicabs were allowed to ferry just one passenger at a time, severely limiting their means to earn a living.

WHEREAS, in response, the Sangguniang Bayan of Lingayen enacted SB Ordinance No. 82, S-2020, prescribing a tariff rate that is applicable during times of community quarantine and similar circumstances.

WHEREAS, Inter-Agency Task Force (IATF) Resolution No. 163-A dated February 27, 2022, placed the province of Pangasinan under Alert Level 2.

WHEREAS, the undersigned issued Executive Order No. 12, Series of 2022, providing for the Guidelines in the Municipality of Lingayen under Alert Level 1.

WHEREAS, under the said Executive Order, public transportation, which includes tricycles and pedicabs, was allowed full seating capacity.

WHEREAS, the conditions under which SB Ordinance No. 82, S-2022 no longer apply.

NOW THEREFORE, by virtue of the powers vested in me by law, I, LEOPOLDO N. BATAOIL, hereby order as follows:

Starting March 1, 2022, the tariff rate applicable for tricycles and pedicabs in the Municipality of Lingayen shall be that which is prescribed under *Sangguniang Bayan (SB) Ordinance No. 25, S-2014*, as amended by *SB Ordinance No. 46, 2015*, to wit:

Minimum Rate . . .	₱10.00 for the first 3 kilometers and an additional ₱2.00 for every additional kilometer
