AN ORDER CREATING AND ORGANIZING LOCAL ECONOMIC DEVELOPMENT AND INVESTMENT COMMITTEE

WHEREAS, Section 19 of the Philippine Constitution provides in substance that the State shall develop a self-reliant and independent national economy effectively controlled by Filipinos;

WHEREAS, local governments should play an active role in attracting more investments that will generate and enhance economic activities in the area;

3. Assist in the conduct of information dissemination on local government policies on investment, investment wage law, required wage law, requires permits, etc.;
4. Coordinate with the private sector in investment promotion of economic activities;
5. Coordinate with the private sector in investment promotion campaigns;
