EXECUTIVE ORDER NO. 59, SERIES OF 2022

**ORGANIZING THE HEALTH EMERGENCY RESPONSE TEAM IN THE
MUNICIPALITY OF LINGAYEN**

WHEREAS, the Department of Health issued Administrative Order No. 2019-0046 or the National Policy on Disaster Risk Reduction and Management in Health that provides strategies for the institutionalization of disaster risk reduction and management in health (DRRM-H) at all levels of the health system;

WHEREAS, it is indispensable for the LGU of Lingayen to strengthen capacities of communities to anticipate, cope and ensure early recovery from the negative health impacts of emergencies and disasters by adopting a systematic approach of integrating DRRM-H in the local health system of the LGU.

WHEREAS, Executive Order No. 58 Series of 2022, provides that the Municipal Government, through the Municipal Health Office, shall organize and mobilize its Health Emergency Response Team (HERT) to respond at the forefront of disasters and health emergencies in accordance with DOH Administrative Order No. 2018-0018 or the National Policy on the Mobilization of Health Emergency Response Teams.

NOW THEREFORE, I, LEOPOLDO N. BATAOIL, by virtue of the powers vested upon me by law as Municipal Mayor of Lingayen, Pangasinan, do hereby organize the Health Emergency Response Team of the Municipal Government of Lingayen, Pangasinan.

Section 2. Duties and Functions. The duties and functions of the HERT shall be in accordance with DOH Administrative Order No. 2018-0018 or the National Policy on the Mobilization of Health Emergency Response Teams and other guidelines and policies issued by the Municipal Disaster Risk Reduction and Management Council of Lingayen.

Section 3. Repeal. All Executive Orders, Resolutions and other issuances pertinent to precautionary and preventive measures against COVID-19 shall remain in full force and effect and shall complement whatever is provided in this Order. However, provisions thereof which are inconsistent herewith are hereby superseded or modified accordingly.

Section 4. Effectivity. This Order shall take effect immediately upon signing.
