EXECUTIVE ORDER NO. 6, SERIES OF 2022

REORGANIZING THE LOCAL PUBLIC TRANSPORT ROUTE PLAN (LPTRP) TEAM OF LINGAYEN, PANGASINAN

WHEREAS, the Omnibus Franchising Guidelines (DOTr DO 2017-011) dated June 19, 2017 regulates guidelines on the planning and identification of public road transportation services and franchise issuance;

WHEREAS, the DILG – DOTr Joint Memorandum Circular No. 1 series of 2017 dated June 19, 2017 issued guidelines on the preparation and issuance of local ordinances, orders, rules and regulations concerning the local public transport route plan (LPTRP);

WHEREAS, the DILG Memorandum Circular No. 2018-60 mandates the Local Governments (LGUs) to prepare, submit and adopt Local Public Transport Route Plan (LPTRP) as basis of Land Transportation Franchising Regulatory Board (LTFRB) for the issuance of franchises to public utility vehicles dated May 3, 2018;

WHEREAS, Executive Order No. 12, Series of 2020 created and mobilized the Local Public Transport Route Plan (LPTRP) Team of the Municipality.

WHEREAS, there is a need to reorganize the Local Public Transport Route Plan (LPTRP) Team to include members essential in the attainment of its objectives and goal and to replace members no longer in the agency or organizations they are representing;

NOW, THEREFORE, I LEOPOLDO N. BATAOIL, Municipal Mayor of the Local Government Unit of Lingayen, by virtue of the powers vested in me by law, do hereby order:

SECTION I: COMPOSITION. The Lingayen Public Transport Route Plan Committee (LPTRP Team) shall be organized in the Municipality of Lingayen and shall be composed of the following:

SECTION II: FUNCTIONS & DUTIES OF THE LPTRP TEAM

1. Review available plans and documents and gather data required in the development of LPTRP.
2. Prepare and issue survey forms required for consolidation and analysis of the current public transport system.
3. Identification and assessment of problems and issues in local public transport system.
4. Formulate local public transport route plan based on and/or consistent with the manual prescribed in joint Memorandum Circular No. 001, series of 2017, dated 19 June, 2017 of the Department of Interior and Local Government (DILG) and Department of Transportation (DOTr);
5. Submit to the Land Transportation Franchising and Regulatory Board (LTFRB) for review, copy furnished the Department of Interior and Local Government (DILG).

SECTION III: SUPPORT REQUIREMENTS

The team may call upon the assistance of relevant units and/or LGU personnel, through the respective department/ unit heads, in the implementation of various activities.

SECTION IV: EFFECTIVITY

The LPTRP Team shall exercise their functions and duties immediately.
