**EXECUTIVE ORDER NO. 43-B, SERIES OF 2021**

**GIVING FULL EFFECT TO EXECUTIVE  
ORDER NO. 43, SERIES OF 2021**

WHEREAS, Article II, Section 5, of the 1987 Constitution recognizes that the maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy.

WHEREAS, under Article II, Section 15, of the 1987 Constitution, it is the policy of the State to protect and promote the right to health of the people and instill health consciousness among them.

WHEREAS, Section 16 of the Local Government Code of 1991 empowers local government units to exercise the powers which are essential to the promotion of the general welfare, health, and safety within their respective territorial jurisdictions.

WHEREAS, the undersigned issued Executive Orders Nos. 40,<sup>1</sup> 41,<sup>2</sup> and 42,<sup>3</sup> Series of 2021 to abate the rise of COVID-19 cases in the Municipality.

WHEREAS, on August 27, 2021, Governor Amado I. Espino III issued Letter Circular No. 2021-0159 enjoining LGUs to implement emergency measures to address the recent spikes of COVID-19 cases in Pangasinan.

WHEREAS, on August 31, 2021, the undersigned issued Executive Order No. 43 implementing heightened restrictions in the Municipality of Lingayen in anticipation of the National IATF's resolution placing the entire province under heightened General Community Quarantine.

WHEREAS, pending the issuance of a formal Resolution placing the entire Municipality under GCQ, the undersigned issued Executive Order No. 43-B suspending the implementation of certain provisions of Executive Order No. 43.

WHEREAS, on September 7, 2021, the National IATF issued Resolution No. 136-F placing the entire province of Pangasinan under General Community Quarantine With Heightened Restrictions.

NOW THEREFORE, I, LEOPOLDO N. BATAOIL, by virtue of the powers vested in me by law, hereby order the following:

1. All the provisions of Executive Order No. 43, Series of 2021, are now in full force and effect.
2. Food preparation establishments such as, but not limited to commissaries, restaurants, eateries, fast food chains, cafes, and the like may operate with their indoor dine-in services at the venue or seating capacity of twenty percent (20%), and with their al fresco or outdoor dine-in services at the venue or seating capacity of fifty percent (50%).
3. The Liquor Ban in the Municipality of Lingayen is further extended until September 30, 2021.
