### EXECUTIVE ORDER NO. 45, SERIES OF 2021

#### IMPOSING A MODIFIED LIQUOR BAN IN THE MUNICIPALITY OF LINGAYEN

WHEREAS, Article II, Section 5, of the 1987 Constitution recognizes that the maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy.

WHEREAS, under Article II, Section 15, of the 1987 Constitution, it is the policy of the State to protect and promote the right to health of the people and instill health consciousness among them.

WHEREAS, Section 16 of the Local Government Code of 1991 empowers local government units to exercise the powers which are essential to the promotion of the general welfare, health, and safety within their respective territorial jurisdictions.

WHEREAS, the undersigned issued Executive Orders Nos. 40,<sup>1</sup> 41,<sup>2</sup> 42,<sup>3</sup> and 43,<sup>4</sup> Series of 2021, to abate the rise of COVID-19 cases in the Municipality.

NOW THEREFORE, I, LEOPOLDO N. BATAOIL, by virtue of the powers vested in me by law, hereby order the following:

**Section 1.** Effective October 01, 2021, **the sale, purchase, distribution, and drinking of alcoholic beverage in the confines of one's own home is hereby permitted.** However, the **drinking of alcoholic beverage in a public place is still not allowed.**

**Section 2.** "Alcoholic beverage" includes any beverage in liquid form which contains not less than one-half of one percent of alcohol by volume and is intended for human consumption.

**Section 3.** "Public places" means all places, fixed or mobile, that are accessible or open to the public or places for collective use, regardless of

ownership or right to access, including but not limited to, schools, workplaces, government facilities, establishment that provide food and drinks,

accommodation, merchandise, professional services, entertainment or other services. It also includes outdoor spaces where facilities are available for the public or where a crowd of people would gather, such as, but not limited to, playgrounds, sports ground or centers, church grounds, health/hospital compounds, transportation terminals, market, parks, resorts, walkways/sideways, entrance ways, waiting areas, and the like.
