EXECUTIVE ORDER NO. 8, SERIES OF 2021

**AMENDING SECTION 1 OF EXECUTIVE
ORDER NO. 14, SERIES OF 2020**

WHEREAS, on February 24, 2020, the undersigned issued Executive Order No. 14, Series of 2020, creating the Inter-Agency Task Force for the Management of COVID-19 in the Municipality of Lingayen.

WHEREAS, there is a need to strengthen the composition of the Municipal Inter-Agency Task Force for the Management of COVID-19 to better perform its functions.

NOW THEREFORE, I, LEOPOLDO N. BATAOIL, Municipal Mayor of Lingayen, Pangasinan, by virtue of the powers vested in me by law, do hereby order the amendment of Section 1 of Executive Order No. 14, Series of 2020, to read as follows:

SECTION 1. Section 1 of Executive Order No. 14, Series of 2020, is hereby amended to read as follows:

SECTION 1. CREATION AND COMPOSITION. The Task Force on COVID-19 hereinafter referred to as the "Task Force" is hereby created, to be composed of the following:

“The Task Force may call upon any department, office, agency, Civil Society Organization, and the private sector for assistance as the circumstances and exigencies may require.

“Further, the Chairperson of the Task Force may enlist the Armed Forces of the Philippines to supplement the Philippine National Police and other law enforcement agencies for the purpose of enforcing health, safety, and quarantine protocols or facilitating the transport of patients, and for such other purposes for the implementation of this Order.

“Moreover, Municipal Health Office shall be the Office of Primary Responsibility for the implementation of this Executive Order and subsequent Resolutions and courses of action approved by the Task Force.”

SECTION 2. This Executive Order shall take effect immediately.
