### EXPLANATORY NOTE

WHEREAS, Municipal Ordinance No. 17, S-2014 was enacted by the Sangguniang Bayan of Lingayen amending Section 6 and Section 7 of Municipal Ordinance No. 6, S-2012, indicating therein that the date of "Bagoong Festival" shall be held on the third week of January every year as may be decided by the Local Chief Executive which specific day/s will be its celebration including the allocation of fund for the purpose;

WHEREAS, after further study by the Sangguniang Bayan of Lingayen, it was agreed and approved that the festivity/celebration be held on the third week of March every year thereby granting authority to the Local Chief Executive to decide which specific day/s will be its celebration;

WHEREAS, as part of its promotional schemes, the Municipality of Lingayen must be able to declare "Bagoong Festival" as its official celebration, apart from the Capital Town's Festival, to acknowledge the said product and its producers/makers thereby a need to increase the allocated fund from One Million (P1M) Pesos to Two Million (P2M) Pesos to ensure the success of the festivity as well as promote tourism in the municipality;

WHEREAS, the transfer of the date of the celebration is to give more time to prepare for the "Bagoong Festival" considering that the Capital Town Festival is being celebrated on the first week of January which is too close to the Bagoong Festival;

WHEREFORE, on motion of SBM John Silvester A. Tapia duly seconded by SBM Ramon Anselmo M. Cuaresma and SBM Mac Dexter G. Malicdem respectively, be it:

**ORDINANCE NO. 75, S-2019**

**AN ORDINANCE AMENDING SECTION 1 AND SECTION 2 OF MUNICIPAL ORDINANCE NO. 17, S-2014 OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN.**

Be it enacted by the Sangguniang Bayan of Lingayen, Pangasinan in session duly assembled that:

**SECTION 1.** The celebration of the "Bagoong Festival" which is being celebrated every third week of January every year shall be held on the third week of March every year thereafter and shall be decided by the Local Chief Executive which specific day/s will be its celebration.

**SECTION 2.** The appropriation of ONE MILLION (P1M) PESOS for the "Bagoong Festival" shall be increased to TWO MILLION (P2M) PESOS that shall be allocated in the Annual Budget of the municipality.

**SECTION 3. SEPARABILITY CLAUSE.** All provisions of Municipal Ordinance No. 6, S-2012 not otherwise repealed, modified or amended shall remain effective and valid.

**SECTION 4. EFFECTIVITY.** This ordinance shall take effect upon approval by the Sangguniang Panlalawigan of Pangasinan.


