

**EXPLANATORY NOTE**

WHEREAS, Municipal Ordinance No. 43, S-2015 entitled, “An ordinance on the prevention, control and abatement of the mosquito vector of dengue and providing fines and penalties thereof, subject to all laws and existing legal rules and regulations also known as the Anti-Dengue Ordinance of Lingayen” was enacted by the Sangguniang Bayan of Lingayen as a basis for the implementation of policies, guidelines and programs on the prevention and control of dengue;

WHEREAS, there is a need to amend Section 8.1 (Creation and Composition) by just indicating the designated position/s thereby deleting the name/s of the person/s concerned;

WHEREAS, the objective of the amendment is for the ordinance to have permanent status and to refrain from frequent amendment in case of change of administration nor change of designated department heads or persons concerned;

WHEREFORE, on motion of SBM Mac Dexter G. Malicdem duly seconded by SBM Jay Mark Kevin D. Crisostomo, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to enact this corresponding ordinance.

**ORDINANCE NO. 77, S-2019**

**AN ORDINANCE AMENDING SECTION 8.1 (CREATION AND COMPOSITION) OF MUNICIPAL ORDINANCE NO. 43, S-2015 OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN.**

Be it ordained by the Sangguniang Bayan of Lingayen, Pangasinan in session assembled that:

**SECTION 1.** This ordinance shall be known as the Anti-Dengue Ordinance of Lingayen, Pangasinan.

**SECTION 2.** Section 8.1 which is the Creation and Composition of the Anti-Dengue Task Force is hereby amended by just indicating the designated position/s.

**SECTION 3. SEPARABILITY CLAUSE.** All provisions of Municipal Ordinance No. 43, S-2015 not otherwise repealed, modified or amended shall remain effective and valid.

**SECTION 4. EFFECTIVITY.** This ordinance shall take effect upon approval by the Sangguniang Panlalawigan of Pangasinan.
