EXPLANATORY NOTE

WHEREAS, the Municipality of Lingayen will be placed under General Community Quarantine from May 16, 2020, until May 31, 2020, or until earlier lifted or extended as circumstances warrant;

WHEREAS, under the guidelines provided by the Department of Transportation, tricycles and pedicabs are allowed to operate under the General Community Quarantine provided that tricycles and pedicabs must not exceed one passenger in the side-car, while back riding will not be allowed;

WHEREAS, this body recognizes the necessity of the tricycle driver and pedicab driver to earn their daily bread and the need of the commuting public to a fair and equitable fare under the circumstances;

WHEREFORE, on motion of SBM John Silvester A. Tapia, duly seconded by SBM Jay Mark Kevin D. Crisostomo and SBM Ramon Anselmo M. Cuaresma, respectively, be it:

ORDINANCE NO. 82, S-2020

REGULATING THE POLICIES, RULES, AND OPERATION OF TRICYCLES AND PEDICABS IN THE MUNICIPALITY OF LINGAYEN DURING TIMES OF COMMUNITY QUARANTINE AND SIMILAR CIRCUMSTANCES.

Be it enacted by the Sangguniang Bayan of Lingayen, Pangasinan in session duly assembled THAT:

Section 1. *Short Title.* - This Ordinance shall be known as the "Tricycle and Pedicab Fares Under Special Circumstances Ordinance of 2020".

Section 2. *Coverage.* - This ordinance shall cover all tricycles and pedicabs, their drivers and operators, and all TODAs and PODAs in Lingayen, Pangasinan, while the Municipality of Lingayen or any part thereof is under General Community Quarantine, any form of Community Quarantine, or similar circumstances wherein only one passenger is allowed in the side-car per tricycle or per pedicab, and back-riding is not allowed.

Section 3. *Minimum Safety Standards.* - All tricycle drivers and pedicab drivers are mandated to use face masks and gloves while engaged in their occupation.

Section 4. Disinfecting of vehicles and terminals. Thorough disinfecting practices of vehicles, terminals, and even among passengers are required.

Section 5. Tricycles and pedicabs must not exceed one passenger in the side-car, while back riding will not be allowed.

Section 6. *Tariff Rate.* - The tariff rate is as follows:

Minimum rate - P20.00 for the first 3 kilometers and
P4.00 additional per succeeding kilometer

Discount rate (Students, Senior citizens, Persons With Disability)
- P16.00 for the first 3 kilometers and
P4.00 additional per succeeding kilometer.

Special trip — Fare shall be upon agreement of the driver and passenger.

Section 7. *Repealing Clause.* - All other ordinances, resolutions, rules and regulations or parts thereof inconsistent with the provisions of this Ordinance are hereby expressly repealed, amended or modified accordingly.

Section 8. *Effectivity.* This ordinance shall take effect upon its approval.



RESOLUTION NO. 502-2020

DECLARING ORDINANCE NO. 82, S-2020 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING THE POLICIES, RULES AND OPERATION OF TRICYCLES AND PEDICABS IN THE MUNICIPALITY OF LINGAYEN DURING TIMES OF COMMUNITY QUARANTINE AND SIMILAR CIRCUMSTANCES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Ordinance No. 82, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (3) (vi) of RA 7160; and consistent with existing guidelines issued by the IATF-EID and the Department of Transportation; and Section 5 (A) (4) of Executive Order No. 0024-2020 of the Province of Pangasinan, as amended;

WHEREAS, subject ordinance shall take effect after the Sanggunian has complied with the requirement of posting pursuant to Section 59 (b) of RA 7160;
