EXPLANATORY NOTE

WHEREAS, Section 4 (z) of Republic Act No. 11469 (Bayanihan to Heal as One Act) authorizes the President to “move statutory deadlines and timelines for the filing and submission of any document, the payment of taxes, fees, and other charges required by law, and the grant of any benefit in order to ease the burden of individuals under Community Quarantine”;

WHEREAS, as per Department of Finance Circular No. 002-2020 dated April 23, 2020, the deadlines for the payment of taxes, fees and charges imposed and collected by the Local Government Units as of March 25, 2020, was extended until June 25, 2020;

WHEREAS, the moratorium granted by the Department of Finance may not be enough to alleviate the plight of the lessees of the Lingayen Public Market considering that most of the market stalls in Lingayen were closed until May 15, 2020, due to the Enhanced Community Quarantine;

WHEREAS, this Body recognizes the necessity to extend the moratorium for payment of market stall rentals past June 25, 2020, to help lessees who are still reeling from the economic disruption brought about by the Enhanced Community Quarantine;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo duly seconded by SBM Jonathan Carl R. Arcinue, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to enact this corresponding ordinance.

ORDINANCE NO. 88, S-2020

AN ORDINANCE EXTENDING THE DEADLINE FOR THE PAYMENT OF MARKET STALL RENTALS UNTIL OCTOBER 25, 2020.

Be it enacted by the Sangguniang Bayan of Lingayen, Pangasinan in session duly assembled that:

SECTION 1. COVERAGE – This ordinance shall cover all existing lease contracts governed by **ORDINANCE NO. 18, S-2014**, as amended, otherwise known as the "*The Market Code of the Municipality of Lingayen, Province of Pangasinan.*"

SECTION 2. EXTENSION OF DEADLINES FOR THE PAYMENT OF LEASE RENTALS IN THE LINGAYEN PUBLIC MARKET – The deadlines for the payment of all lease rentals at the Lingayen Public Market for the months of April, May, June, 2020 shall be extended until 25 October 2020. Further, the counting of the period within which to pay lease rental shall likewise be suspended during the said period.

SECTION 3. NON-APPLICATION OF INTEREST, SURCHARGE AND OTHER PENALTY – As a result of the moving of dealines of payment and the suspension of the counting of the period within which to pay market stall lease rentals, no interest, surcharge or any form of penalty shall be applied on any market stall lease rental accruing on or due and demandable during the period provided in Section 2 hereof.

SECTION 4. REPEALING CLAUSE – All other ordinances, resolutions, rules and regulations or parts thereof inconsistent with the provision of this Ordinance are hereby expressly repealed, amended or modified accordingly.

SECTION 5. EFFECTIVITY. This ordinance shall take effect immediately upon its approval.





RESOLUTION NO. 637-2020

DECLARING ORDINANCE NO. 88, S-2020 OF THE SANGGUNIANG BAYAN OF LINGAYEN, PANGASINAN, ENTITLED "AN ORDINANCE EXTENDING THE DEADLINE FOR THE PAYMENT OF MARKET STALL RENTALS UNTIL OCTOBER 25, 2020" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Ordinance No. 88, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 192 of RA 7160; Section 4 (2) of RA 11469 known as the "Bayanihan to Heal as One Act"; and Department of Finance Circular No. 002-2020;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject ordinance in order;

WHEREFORE, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 88, S-2020 of the Sangguniang Bayan of **Lingayen**, Pangasinan, entitled "An Ordinance extending the deadline for the payment of market stall rentals until October 25, 2020" as within the conferred powers of the Sangguniang Bayan to enact;




