RESOLUTION NO. 10, S-2019

AUTHORIZING HONORABLE MAYOR LEOPOLDO N. BATAOIL, REPRESENTING THE LOCAL GOVERNMENT UNIT OF LINGAYEN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH DRUGSTORES, HOSPITALS, FUNERAL PARLORS, SUPERMARKET/GROCERY STORES, CIVIL SOCIETY ORGANIZATIONS AND OTHER SERVICE PROVIDERS FOR THE IMMEDIATE AND NECESSARY RELIEF, RESCUE AND RESPONSE OPERATIONS DURING DISASTERS.

WHEREAS, the Local Disaster Risk Reduction Management Office (LDRRMO), created pursuant to R.A. No. 10121, otherwise known as the Philippines Disaster Risk Reduction Management Act of 2010 is task to develop, strengthen and operationalize mechanism for partnership or networking with the private sectors, CSOs and volunteer groups;

WHEREAS, as mandated by law, Local Government Units shall ensure the delivery of basic services and adequate facilities within their respective territorial jurisdiction;

WHEREAS, the Memorandum of Agreement (MOA) between the municipality and the different service providers is in compliance with the preparation of disaster eventualities to carry out effectively and efficiently the functions in order to mitigate the adverse effect of the calamity;

WHEREAS, in addition, LGUs shall develop capabilities to sustain the continuous delivery of supplies such as food, shelter, medicines and offer basic needs;

WHEREAS, the Memorandum of Agreement (MOA) entered into by both parties shall form as an integral part of this resolution.

WHEREFORE, on motion of SBM John Silvester A. Tapia duly seconded by all, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize Honorable Mayor Leopoldo N. Bataoil, representing the Local Government Unit of Lingayen to enter into a Memorandum of Agreement (MOA) with drugstores, hospitals, funeral parlors, supermarket/grocery stores, civil society organizations and other service providers for the immediate and necessary relief, rescue and response operations during disasters.


