AUTHORIZING HONORABLE MAYOR LEOPOLDO N. BATAOIL, REPRESENTING THE MUNICIPALITY OF LINGAYEN, PANGASINAN TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE (DA) REGARDING PHILIPPINE RURAL DEVELOPMENT PROJECT (PRDP).
