REQUESTING HON. WENDEL E. AVISADO, ACTING SECRETARY OF THE DEPARTMENT OF BUDGET AND MANAGEMENT, TO ALLOCATE AND RELEASE FUND AMOUNTING TO FIFTY MILLION PESOS (P50,000,000.00) FOR THE CONSTRUCTION OF RIVER BANK PROTECTION OF SAN JOSE RIVER, THIS MUNICIPALITY.

WHEREAS, San Jose River is one of the major rivers in Lingayen that traverses barangays Libsong West, Poblacion and Pangapisan Sur;

WHEREAS, said river is vital in holding the bulk of water from water sheds going to the mouth of the Agno River and to ensure its free and smooth flow, dredging was initially done and now there is a need for concreting and upgrading of its riverbanks in order to prevent flooding of nearby residential areas and the town proper itself;

WHEREAS, the LGU of Lingayen is committed in preserving, rehabilitating and beautifying its ecological resources not just for the safety of its inhabitants but also to enhance its appeal to locals and tourists alike;

WHEREAS, the Municipal Government do not have the financial resource to undertake the project hence the need to source out funds from national agencies;

WHEREFORE, on motion of SBM John Silvester A. Tapia duly seconded by all, be it:


