**A RESOLUTION URGING THE LOCAL GOVERNMENT UNIT OF LINGAYEN TO JOIN IN COMMEMORATING VICTIMS OF ROAD ACCIDENTS BY CELEBRATING THE "WORLD DAY OF REMEMBRANCE FOR ROAD TRAFFIC VICTIMS ON THE 3<sup>RD</sup> WEEK OF NOVEMBER.**

WHEREAS, vehicular accidents in the Province of Pangasinan have become significant in the last three (3) years;

WHEREAS, the Municipality of Lingayen has also experienced a rise in vehicular accidents;

WHEREAS, most of these accidents involved motorcycles and tricycles and majority of the victims are children or adolescents;

WHEREAS, these are not localized incidents but are considered a problem of the world over;

WHEREAS, this is the reason why every third (3<sup>rd</sup>) Sunday of November is declared as "World Day of Remembrance for ROAD TRAFFIC VICTIMS";

WHEREAS, said observance aims to reduce road casualties by raising awareness and also to pay tribute to emergency crews, police and medical professionals who deal with the traumatic aftermath of road death and injury;
