#### APPROVING THE REALIGNMENT OF PROJECT TITLE FROM THE CONSTRUCTION OF INFORMATION CENTER PHASE II TO REHABILITATION OF DRAINAGE CANAL AT BARANGAY LIBSONG WEST, THIS MUNICIPALITY.

WHEREAS, the Municipality of Lingayen has allocated an amount of Two Hundred Thousand Pesos (P200,000.00) for the construction of Information Phase II under the Capital Outlay for CY 2019 as financial assistance for Barangay Libsong West;

WHEREAS, said amount is intended for the construction of Information Phase II but due to the clearing operation being undertaken by the municipality, the proposed construction of the building will be affected thereby a need to realign said project that will benefit the constituents;

WHEREAS, the Barangay Council of Libsong West unanimously agreed to realign said amount from construction of Information Phase II to rehabilitation of drainage canal in order to ease the perennial problem of flooding in the barangay;
