Sirs:

Pursuant to the provisions of the Local Government Code of 1991, we are respectfully forwarding for your review the **Supplemental Budget No. 2 for Calendar Year 2019** of the Municipality of Lingayen, Pangasinan involving total appropriations of **P22,623,081.36** which was enacted by the Sangguniang Bayan of said municipality on **November 28, 2019** through Appropriation Ordinance No. 2, S-2019.

The Local Finance Committee in compliance with Section 316 of the Code has conducted preliminary review on said budget and reveals substantial compliance with the same law and its Implementing Rules and Regulations. Said Supplemental Budget may be declared **operative in its entirety** as of the date fixed in the appropriation ordinance subject however to the following conditions:

1. That the grant of Collective Negotiation Agreement (CNA) Incentive for FY 2019 to officials and employees of the municipality shall be in accordance with the provisions of Budget Circular No. 2019-5 of the Department of Budget and Management dated November 7, 2019;
2. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2019 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, series of 2007 dated March 8, 2007;
3. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations; and
4. That the funding sources for the subject supplemental budget were determined in accordance Section 321 of R.A. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993.

It is understood that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

Compliance with all existing laws, rules and regulations shall be the responsibility of the Municipal Government of Lingayen.

Dear Sirs/Mesdames:

This has reference to Sangguniang Bayan **Resolution No. 120, S-2019** of the Sangguniang Bayan of **Lingayen, Pangasinan**, entitled: "A RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) FOR CY 2019 OF THE MUNICIPALITY OF LINGAYEN, PANGASINAN", which you have requested our office for technical study and recommendation.

Based on the preliminary review conducted by this office, hereunder are our findings:

1. **Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991.** The Local Development Council of Lingayen, Pangasinan had identified items in their Supplemental Investment Program. This was endorsed to the Sangguniang Bayan for approval on November 20, 2019 thru MDC Resolution No. 06, Series of 2019 and was favorably acted upon by the Sangguniang Bayan on November 28, 2019 thru SB Resolution No. 120, Series of 2019.
2. The Supplemental Investment Program of the municipality covers fund augmentation for the Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of various municipal government offices and for the operation of the Market and Slaughterhouse and implementation of development projects and disaster risk reduction programs of the municipality.
3. The proposed Supplemental Investment Program has an investment requirement of P22,623,081.36. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 2 Series 2019, which was passed and approved by their Sangguniang Bayan on November 28, 2019 thru Appropriation Ordinance No. 2, series of 2019.

In view of the above findings, Resolution No. 120, S-2019 of Lingayen, Pangasinan, may **be considered favorably** by the Provincial Board.
