WHEREAS, the Urbiztondo-Lingayen road is considered as the main thoroughfare of vehicles and commuters alike in going to and fro the southern barangays to the town proper;

WHEREAS, the asphalt overlay of the road have caused the existence of big potholes causing inconvenience to motorists, workers, students, residents and other commuters;


