RESOLUTION NO. 143, S-2020

AUTHORIZING HON. MAYOR LEOPOLDO N. BATAOIL TO DONATE FIVE HUNDRED THOUSAND PESOS (P500,000.00) FROM THE CALAMITY FUND OF THE MUNICIPALITY TO THE LEAGUE OF MUNICIPALITIES OF THE PHILIPPINES, BATANGAS CHAPTER FOR THEIR RELIEF AND REHABILITATION EFFORTS.

WHEREAS, the province of Batangas was devastated due to the eruption of Taal Volcano leaving enormous numbers of residents homeless, hungry and thirsty and killing thousands of animals;

WHEREAS, the devastation caused by the eruption of Taal Volcano, considered one of the country's worst natural disasters, has been catastrophic as it brought massive ashfalls which brought billions of damages to agriculture, school buildings, houses and other infrastructures;

WHEREAS, the Municipality of Lingayen, Pangasinan opted to extend financial assistance in the amount of FIVE HUNDRED THOUSAND PESOS (P500,000.00) to the devastated Province of Batangas through the League of Municipalities of the Philippines, Batangas Chapter;

WHEREAS, the humanitarian gesture of the Municipality of Lingayen, Pangasinan will greatly benefit thousands of families in the Province of Batangas that were affected by the wrath of the eruption of Taal Volcano;

WHEREAS, considering that the amount for donation is available and there is still suitable amount left in case of calamity in our area, the act or gesture of extending financial assistance to victims of eruption of Taal Volcano is in response to the call of the national government as well as the international community to help our affected brothers and sisters;

WHEREAS, the utilization of fund of the present Local Calamity Fund shall be drawn from the Local Disaster Risk Reduction and Management Fund (LDRRMF) which allows the Local Government Units (LGUs) to use its Quick Response Fund or stand-by fund for relief and recovery programs in order that situation and living conditions of people in communities or areas stricken by disasters, calamities, epidemics or complex emergencies may be normalized as quickly as possible;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo duly seconded by ALL, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize the Hon. Mayor Leopoldo N. Bataoil to donate Five Hundred Thousand Pesos (P500,000.00) from the calamity fund of the municipality to the League of Municipalities of the Philippines, Batangas Chapter for their relief and rehabilitation efforts.

RESOLVED FURTHER, that copies of this resolution be furnished the Municipal Mayor, Municipal Budget Officer, Municipal Accountant, Municipal Treasurer and the Municipal Disaster Risk Reduction and Management Council for their information and guidance.

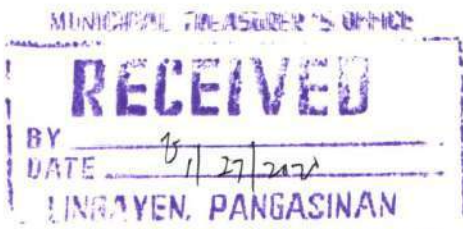
