WHEREAS, all fees for documents needed like birth certificates, affidavit of cohabitation, pre-marriage and family planning seminar, registration fee, marriage license and processing fee are consequently waived to unburden the marrying parties;

WHEREAS, it is the intent of the LGU to erase the stigma of illegitimate children, especially children of indigent parents, and allow them to grow normally and establish their legal rights as legitimate offsprings;
