THIS IS TO CERTIFY that at the Regular Session duly constituted of the Sangguniang Bayan of Lingayen, Pangasinan held on January 27, 2020, at Lingayen, Pangasinan, the following resolution was approved.

RESOLUTION NO. 154, S-2020

DECLARING AMENDMENT NO. 1 TO TAX ORDINANCE NO. 002, S-2019 OF THE SANGGUNIANG BARANGAY OF MALIMPUEC, LINGAYEN, PANGASINAN, ENTITLED, "AN ORDINANCE AMENDING SECTIONS 1,2,13 AND DELETING SECTION 14 OF TAX ORDINANCE NO. 002, S-2019 OF THE OFFICE OF THE SANGGUNIANG BARANGAY OF MALIMPUEC, LINGAYEN, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BARANGAY TO ENACT.

WHEREAS, the Sangguniang Barangay of Malimpuec, Lingayen, Pangasinan, submitted its Amendment to Tax Ordinance No. 002, S-2019 to the Sangguniang Bayan for review and evaluation pursuant to Section 447 (A) (1) (i) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws of the Sangguniang Bayan of Lingayen have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 391 (a) (1) of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Barangay Council of Malimpuec shall cause the posting of this ordinance in at least two (2) conspicuous places in the barangay in pursuance to Section 59 (a) of R.A. 7160;

WHEREFORE, on motion of SBM Jay Mark Kevin D. Crisostomo, duly seconded by SBM Mac Dexter G. Malicdem, it was:

RESOLVED AS IT IS HEREBY RESOLVED, to declare Amendment No. 1 to Tax Ordinance No. 002, S-2019 of the Sangguniang Barangay of Malimpuec, Lingayen, Pangasinan, entitled "An ordinance amending Sections 1, 2, 13 and deleting Section 14 of Tax Ordinance No. 002, S-2019 of the Office of the Sangguniang Barangay of Malimpuec, Lingayen, Pangasinan", as within the conferred powers of the Sangguniang Barangay to enact.


