#### AUTHORIZING HON. MAYOR LEOPOLDO N. BATAOIL TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH METRO CLARK WASTE MANAGEMENT CORPORATION FOR THE SANITARY LANDFILL SERVICES OF RESIDUAL SOLID WASTES.

WHEREAS, the Metro Clark Waste Management Corporation (MCWMC), a corporation duly organized and existing under the laws of the Republic of the Philippines, with principal office address at Subzone D, Clark Special Economic Zone, represented herein by its President, RUFO COLAYCO;

WHEREAS, the LGU Lingayen, Pangasinan, a Local Government Unit duly organized and existing under the laws of the Republic of the Philippines, with principal office address at Poblacion, Lingayen, Pangasinan, represented herein by its Mayor, HON. LEOPOLDO N. BATAOIL;

WHEREAS, it is the intention of the Municipal Government of Lingayen to renew the services of the Sanitary Landfill operated by the Metro Clark Waste Management Corporation at Capas Tarlac for the year 2020;

WHEREAS, LGU Lingayen on the basis of SB Resolution No. 156, S-2020 is hereby authorizing Hon. Mayor Leopoldo N. Bataoil to enter into a Memorandum of Agreement (MOA) with Metro Clark Waste Management Corporation for disposal of residual solid wastes of the municipality at Metro Clark Sanitary Landfill Facility;

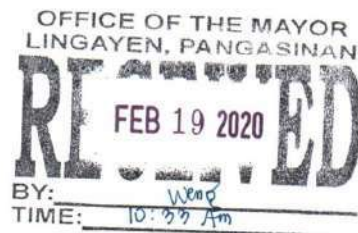
