AUTHORIZING THE HON. MAYOR LEOPOLDO N. BATAOIL TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH PANGASINAN STATE UNIVERSITY TO EXTEND TECHNICAL ASSISTANCE AND REVIEW THE LAND USE DEVELOPMENT AND INFRASTRUCTURE PLAN OF PSU.

WHEREAS, pursuant to the provisions of Republic Act 11396, otherwise known as the LUDIP Act, State Universities and Colleges are required to formulate their Land Use Plans;

WHEREAS, agencies of government are mandated by the said law to extend all assistance needed and necessary to SUCs in crafting their Land Use Plans;

WHEREAS, PSU Lingayen Campus, through University President, Dr. Dexter R. Buted, requested from the LGU through the Honorable Mayor for technical assistance and eventual review of PSU's LUDIP;

WHEREAS, the Honorable Mayor, acting on the said request constituted a Technical and Review Committee for the purpose;

WHEREAS, the terms and conditions of the collaboration are to be embodied in a Memorandum of Agreement between the Local Government Unit and Pangasinan State University;

WHEREAS, the Mayor, being the Local Chief Executive shall represent the LGU and sign in its behalf;


