RESOLUTION NO. 159, S-2020

REQUESTING HON. MAYOR LEOPOLDO N. BATAOIL TO DEPUTIZE THE PHILIPPINE NATIONAL POLICE AND THE BARANGAY OFFICIALS TO INTENSIFY CHECKPOINT FOR QUARANTINE PURPOSES ESPECIALLY IN ENTRY AND EXIT POINT IN THE MUNICIPALITY OF LINGAYEN, PANGASINAN.

WHEREAS, the Novel Corona Virus has been the main health concern not only in China from where it originated but has become a worldwide phenomenon;

WHEREAS, it may not have reached pandemic proportions but it is feared globally because of its highly contagious nature and the fact that there is still no cure for it;

WHEREAS, several countries including the Philippines have put in place preemptive measures to prevent its entry in the country;

WHEREAS, despite these measures, a woman from Wuhan was able to enter the Philippine territory and was confirmed, through diagnostic procedures that she indeed has the N-Cov virus;

WHEREAS, the Municipality of Lingayen should likewise implement deterrents to the possible entry of the disease regardless of the fact that no documented case has been reported in the Province of Pangasinan;

WHEREAS, one of the time and tested procedures in health cases that are highly communicable and transmissible is to set up check points to avoid the entry of possible or potential carriers and quarantine them immediately to prevent the spread of the disease;

WHEREAS, this measure is now being undertaken but there is a need to reinforce the same if only to ensure the Lingayen citizenry are truly protected from contacting the virus;

WHEREFORE, on motion of SBM Mac Dexter G. Malicdem duly seconded by SBM John Silvester A. Tapia and SBM Ramon Anselmo M. Cuaresma, be it:

RESOLVED AS IT IS HEREBY RESOLVED, to request the Hon. Mayor Leopoldo N. Bataoil to deputize the Philippine National Police and the Barangay Officials to intensify checkpoint for quarantine purposes especially in entry and exit point in the Municipality of Lingayen, Pangasinan.


RESOLVED FURTHER, that copies of this resolution be furnished to the Hon. Mayor Leopoldo N. Bataoil, the Chief of Police of Lingayen and the ABC President for their information and appropriate action.
