THIS IS TO CERTIFY *that at the Regular Session duly constituted of the Sangguniang Bayan of Lingayen, Pangasinan held on February 10, 2020, at Lingayen, Pangasinan, the following resolution was approved.*

### **RESOLUTION NO. 167, S-2020**

#### **DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2020 OF BARANGAY DOMALANDAN CENTER, LINGAYEN, PANGASINAN OPERATIVE.**

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Bayan of Lingayen, Pangasinan as a legislative body is empowered to review ordinances authorizing annual or supplemental appropriations of barangays in the manner prescribed by law;

WHEREAS, the Sangguniang Barangay of Domalandan Center, Lingayen, Pangasinan submitted its Annual Budget for Calendar Year 2020 which was approved on December 1, 2019 through Appropriation Ordinance No. 1, S-2019;

WHEREAS, the Committee on Appropriation & Finance of the Sangguniang Bayan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, conducted preliminary review and study on said budget and hereby recommends to declare it OPERATIVE effective as of the date fixed in the Appropriation Ordinance with the following observations/recommendations:

1. That the utilization of appropriations from the 20% Development Fund shall be in accordance with the provisions of DBM-DILG Joint Memorandum Circular No. 2011-1 dated April 13, 2011 specifically Item 3.0 thereof;
2. The disbursement of appropriations for development projects shall be in accordance with the approved Annual Investment Plan of the barangay;
3. All procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 or the Government Procurement Reform Act; *and*
4. SK Fund should be disbursed in accordance with SK Constitution and By-Laws and Youth Development Plan and Budget.
