WHEREAS, the Municipal Administrator shall develop plans and strategies and upon approval thereof by the Mayor, as the case maybe, implement the same particularly those which have to do with the management and administration – related programs and projects which the mayor is empowered to provide under this Code;

WHEREAS, the Municipal Administrator, in addition to the foregoing duties and functions shall assist in the coordination of the work of all officials of the Local Government Unit, under the supervision, direction and control of the Mayor, and for this purpose, he may convene the Chief of Offices and other officials of the Local Government Unit; establish and maintain a sound personnel program for the Local Government Unit; designed to promote career development and uphold the merit principle in the Local Government Service; conduct a continuing organization development of the Local Government Unit with the end view of instituting effective administrative reforms; be in the front line of the delivery of administrative support services, particularly those related to the situations during and in the aftermath of man-made and natural disasters and calamities; recommend to the Sanggunian and advise the Mayor as the case maybe, on all matters relative to the management and administration of the Local Government Unit; and exercise such other powers and perform such other duties and functions as maybe prescribed by law or ordinance;
